



# **II OPEN GALICIA INTERNATIONAL**

BARBANZA PITCH & PUTT- BOIRO- A CORUÑA

4<sup>th</sup>-6<sup>th</sup> July 2014

With the objective of organising a successful International Open which will be celebrated on July 5<sup>th</sup> and 6<sup>th</sup> of 2014, at the Barbanza Pitch & Putt course, the Tournament Committee has established a preliminary pre-inscription date of May 15<sup>th</sup> 2014 in order to ascertain the approximate number of participants attending the tournament, especially those from other FIPPA associations. This will allow the organising committee to estimate the potential dimension of the event. The definitive closing date for inscriptions is May 31<sup>st</sup> 2014.

Those players, pre-inscribed, will have first preference and will be allocated guaranteed participation assuming they comply with the prerequisite norms applied to the competition. In case a FIPPA member association exceeds the suggested limit of available places, every effort will be made to accommodate those players in the likely event of vacancies from other FIPPA member organisations.

## PARTICIPANTS

The initial regulations for inscription are:

5 players reserved for member organisation of FIPPA.

30 players reserved for affiliated playing members of the hosting member ASGAPP.

5 players reserved as invitations at the pleasure of the hosting club.

20 players reserved on behalf of the organising committee.

The Galician Association of Pitch & Putt will determine which Galician players will have direct placement based on the most recent Galician championships and the current Ranking League.

The international competition itself will be held on the  $5^{th}$  and  $6^{th}$  July with a total of 108 participants. There will not be a "cut".

We inform players that in accordance with the new FIPPA regulation with respect to cash prizes for international Open tournaments, the prizes for the I Galician Open will be awarded to best classified players in the general category as follows:

Winner: 400 €; 2<sup>nd</sup> place: 300 €; 3<sup>rd</sup> place: 200 €; 4<sup>th</sup> place: 100 €

In the case of a Tie in any of the classifications, the prize for each player will be the result of dividing the respective accumulated prizes among those players with the same result. A prize winning player may opt to prefer a gift voucher valid for a commercial establishment in Galicia instead of the cash prize.

With respect to the cash prize, the current fiscal tax retention will be applied: For non residents the tax imposed will be 24,75%, and for legal residents, 21%. Players under the age of 18 may only be awarded the gift voucher.

This regulation is intended for players who are registered members of associations affiliated to FIPPA.
